He stated that it is time to start looking in to getting new generators.

Police Sergeant Dan Petersen reported that the ticket numbers are back up. They have been handling complaints and conducting normal patrols. They attended drills at the Hancock Central School. He visited the preschool.

Fire Chief Thomas Rosengrant was not present and the Mayor read his report.

Department of Public Works Superintendent Matt Loftus reported that they are doing normal maintenance. They spread salt for the first snow fall. They cleaned the Water Tank Road for

the upcoming work. They painted and fixed the dump box on T-3. Matt asked the board for a new 10 ton floor jack. He received multiple quotes and the lowest was Auto Plus for \$1,014.00. The Board was in favor of Matt purchasing a floor jack from Auto Plus.
