The Departmental Meeting was called to order at 10:00 AM by Mayor John Martin. Roll call was taken by Clerk/Treasurer Falsetta.

Street & Water Supervisor informed the Board that all equipment is now housed in the storage shed.

The Village Crew has been sucking up leaves that are left on the edges of residents' properties and will continue to do so.

WWTP Chief Operator Wormuth reported that the annual inspection of the WWTP has been conducted. Mayor Martin informed the Board that he has actively been requesting quotes on a new truck for the WWTP. Chief Operator Wormuth stated that they are having problems with leaves getting into the clarifiers but have had no problem accepting sludge from the East Branch rest area.

Code Officer Salvatore's report was reviewed.

Acting Police Chief diLorenzo reported that the Spectrum Justice Computer system is up and running. He is actively researching the Trax system grant for the purchase of a 2<sup>nd</sup> Trax system. The open house that was held on October 11th was very successful. He reported that Officers Petersen and Beers have completed field training school. He attended a criminal history and a sex offender seminar.

Fire Chief Giordano requested permission to purchase LED lighting for the outdoor lights at the firehouse. The cost will be approximately \$300 per light with a total of lights. The new LED lights will be 43 watts opposed to the current 215 watts, so there will be a substantial energy cost saving.

**A MOTION** was made by Mayor Martin seconded by Trustee Gotthardt, voted and 2013-173 carried to change the outside lighting at the firehouse to LED fixtures at an approximate conversion of Lights @ cost of \$1,800.

Fire Chief Giordano reported that he has repaired the hot water heater at the firehouse. The Village crew will be assisting with flushing the heating system at the firehouse on 11/1/13. The tarp that was ripped during the mutual aide call at Trout Creek will cost \$550 to replace. The Board requested that Fire Chief Giordano get price quotes on thermostats. Chief Giordano also requested that a street light be erected at the end of the driveway to the firehouse.

A letter was received from the Rescue Squad informing the Board that the following Members be removed from the Rescue Squad roster due to inactivity (Bylaw Article II,
