A MOTION was made by Trustee Gotthardt, seconded by Trustee Caramore, voted and carried with the exception of Deputy Mayor Shannon who was opposed to authorize Attorney for the Village Nathan VanWhy to sign the settlement agreement with Upper Delaware Inn, LLC and Hancock Cinemas regarding their 2017/2018, 2018/2019 and 2019/2020 Village assessments. It was agreed that the Upper Delaware Inn assessment will be lowered to \$242,865 for the years 2017/2018, 2018/2019 and 2019/2020 with a refund of \$217.15 due. It was agreed that the Hancock Cinemas assessment will be lowered to \$75,000 for the years 2017/2018, 2018/2019 and 2019/2020 with a refund of \$2636.97 due.
