Abstract Approval

The Capital Assets Policy was discussed. The approval was tabled until the Capitalization Threshold amounts can be determined.

A letter was received from the Delaware County Chamber of Commerce requesting that the Village not opt out of the opportunity to allow cannabis-related businesses. The Board had agreed not to opt out at a previous meeting.

Mayor McGrath has written a letter to Rosalind Brewer, CEO of Walgreens expressing her dissatisfaction with the pharmacy hours and periodic closing of the pharmacy due to Hancock's pharmacist being taken to fill positions in other Walgreens that are short handed. She has not yet received a response.

William Brown of Delaware Engineering was present to provide an update on the water and sewer grant projects. Phase II of the Sewer Grant application has been submitted by Mark Blauer and the award should be announced in December/January. New power lines are being installed at the water pump stations. The installation should be completed by next spring and the work will begin on the water tank. Next year NYS DOT will be milling and paving State Route 97, where the water mains were replaced.

Valerie Senese was present to discuss the river access (Junction Pool) at the WWTP. She wanted the Board to be aware that there is a dispute with the NYS DEC as to who controls the area. The DEC is insisting that there is a "memorandum of understanding" in relation to the property but have not yet produced it. The matter is being investigated and will be discussed again once more information is available.

**A MOTION** was made by Trustee Caramore, seconded by Trustee Picozzi, voted and carried at 7:27 PM to enter into executive session to discuss the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation.
