Resolution 2023-5 A RESOLUTION ESTABLISHING CERTAIN WATER FEES UNDER CHAPTER 109 OF THE VILLAGE CODE

WHEREAS, Section 109-9 of the Village Code authorizes the Village Board to set forth certain fees by resolution from time to time; and

WHEREAS, under Section 109-9D, the Village Board may establish service fees related to water shut-offs for nonpayment of bills; and

NOW THEREFORE, the Village Board of the Village of Hancock, duly convened in regular session, does hereby resolve as follows pursuant to Section 109-9

- 1. There shall be a \$50.00 fee for all manual water shut-offs as a result of nonpayment of bills; and
- 2. There shall be a \$10.00 fee for the cost of registered mail for water shut-off notices.
