NOW, THEREFORE, the Village Board hereby adopts said Local Law as Local Law No. 1-2014 entitled "A LOCAL LAW AMENDING THE VILLAGE OF HANCOCK VEHICLE AND TRAFFIC LAW TO MAKE A 3-WAY STOP AT THE INTERSECTION OF LEONARD STREET AND WEST FRONT STREET", a copy of which is attached hereto and made a part hereof; and

THEREFORE, the Village Clerk is hereby directed to enter said Local Law in the minutes of this meeting and to give due notice of the adoption of said Local Law to the Secretary of State.
